This Notice of Addition of Land to the Development Area Declaration of Covenants, Conditions and Restrictions, Georgetown Village Planned Unit Development Section Nine - Phase One ("Notice of Addition"), is made and executed by Wilson Family Communities, Inc., a Texas corporation ("Declarant") and is as follows:

1. This Notice of Addition is filed with respect to Georgetown Village Planned Unit Development Section Nine - Phase One, a subdivision in Williamson County, Texas, according to the map or plat thereof, recorded in Cabinet EE, Slides 296-299, of the Official Public Records of Williamson County, Texas (the "Land").



According to Article VI of that one certain Development Area Declaration of Covenants, Conditions and Restrictions, dated May 7, 1998, recorded in Document No. 9825734, Official Records of Williamson County, Texas, as amended pursuant to that certain First Amendment to Development Area Declaration of Covenants, Conditions and Restrictions, dated September 14, 1998, recorded in Document No. 9855810, Official Records of Williamson County, Texas; Second Amendment to Development Area Declaration of Covenants, Conditions and Restrictions, dated June 29, 1999, recorded in Document No. 199943727, Official Records of Williamson County, Texas; Third Amendment to Development Area Declaration of Covenants, Conditions and Restrictions, dated April 12, 2001, recorded in Document No. 2001026444, Official Records of Williamson County, Texas; Fourth Amendment to Development Area Declaration of Covenants, Conditions and Restrictions, dated May 31, 2005, recorded in Document No. 2005041967, Official Records of Williamson County, Texas; Fifth Amendment to Development Area Declaration of Covenants, Conditions and Restrictions, dated August 8, 2006, recorded in Document No. 2006070621, Official Records of Williamson County, Texas (the "Declaration"), upon the filing of the appropriate Notice of Addition, land may be added to the Declaration, and upon such addition, the Declaration and the covenants, conditions, restrictions and obligations set forth therein shall be the same with respect to the added land as with respect to the lands originally covered by the Declaration.

3. This Notice constitutes a notice of "Addition of Land" under Article VI of the Declaration. The Land is hereby added to the Property as such term is defined in the Declaration and the covenants, conditions, restrictions and obligations set forth in the Declaration shall apply to the Land. Any capitalized terms used and not otherwise defined in this Notice shall have the meaning set forth in the Declaration.

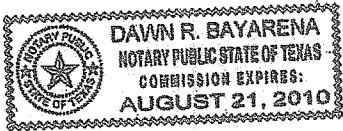

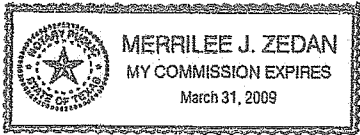
